All bidders must register and receive a bidder number for use at the silent auction and sign the Silent Auction Rules form to confirm they understand the rules of the event.

Bidders are responsible for any bidding with their registered number. It is the responsibility of the bidder to ensure their number is secure and kept confidential.

Bidders must use their bidder number and write their own bid on the bid sheet for their bid to be valid. Verbal bids are not accepted.

Opening bid amount is printed on the bid sheet along with the incremental bid amount. To place a bid on a silent auction item, bidders write in their bidder number and their bid amount on the bid sheet.

Incremental bids that don't meet our minimum incremental bid amount are invalid bids. The minimum incremental bid on all items is \$1.

Auction winners will be announced by their bidder number at the close of each auction.

All sales are final. There will be no exchanges or refunds. Auction items descriptions are provided for guidance only. Kids and Cancer Benefit organization is not responsible for accuracy of the description or condition of items. **All items are sold "as is."**

Winners must pick up their products in person. Proof of ID is required.

Accepted forms of payment are cash, MasterCard, Visa, or Discover.

All items must be claimed and **paid in full within 1 hour from the announcement of winners.** Any item left unclaimed after that time will forfeit their winning products and the next lowest bidder will be notified and offered the package at the winning bid amount. If no bidders are identified, Kids and Cancer Benefit organization reserves the right to offer the package for bidding, raffle, or sale during this auction or any other time or day they deem appropriate.




